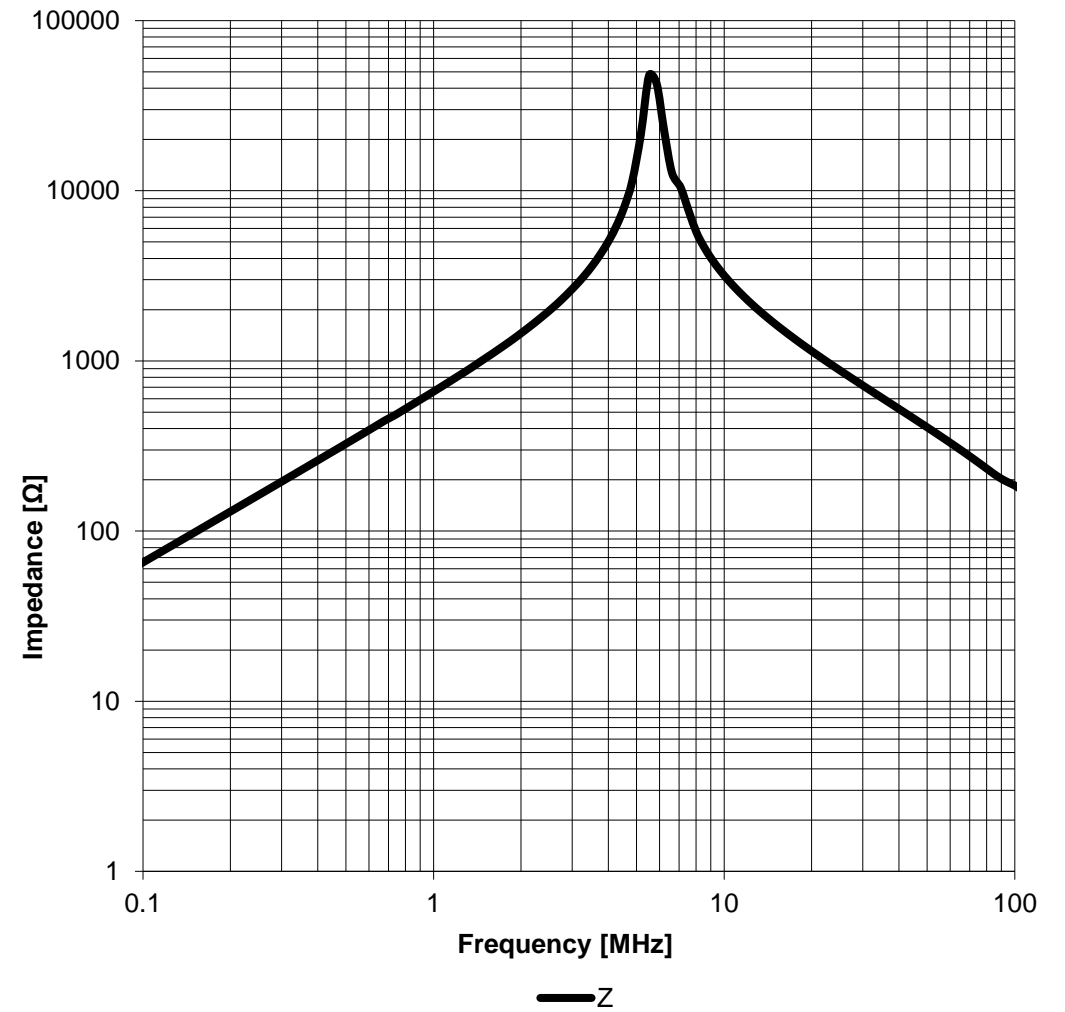

### Typical Inductance vs. Current Characteristics:



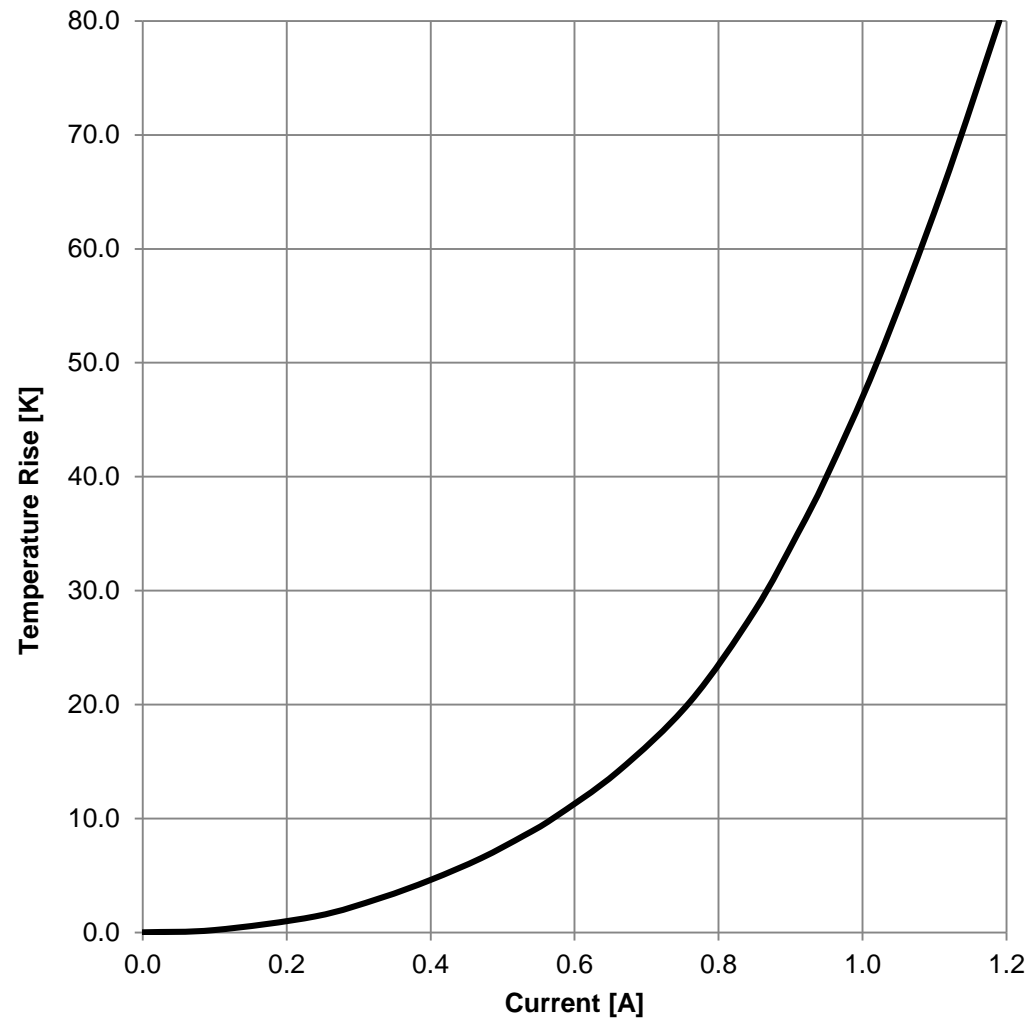



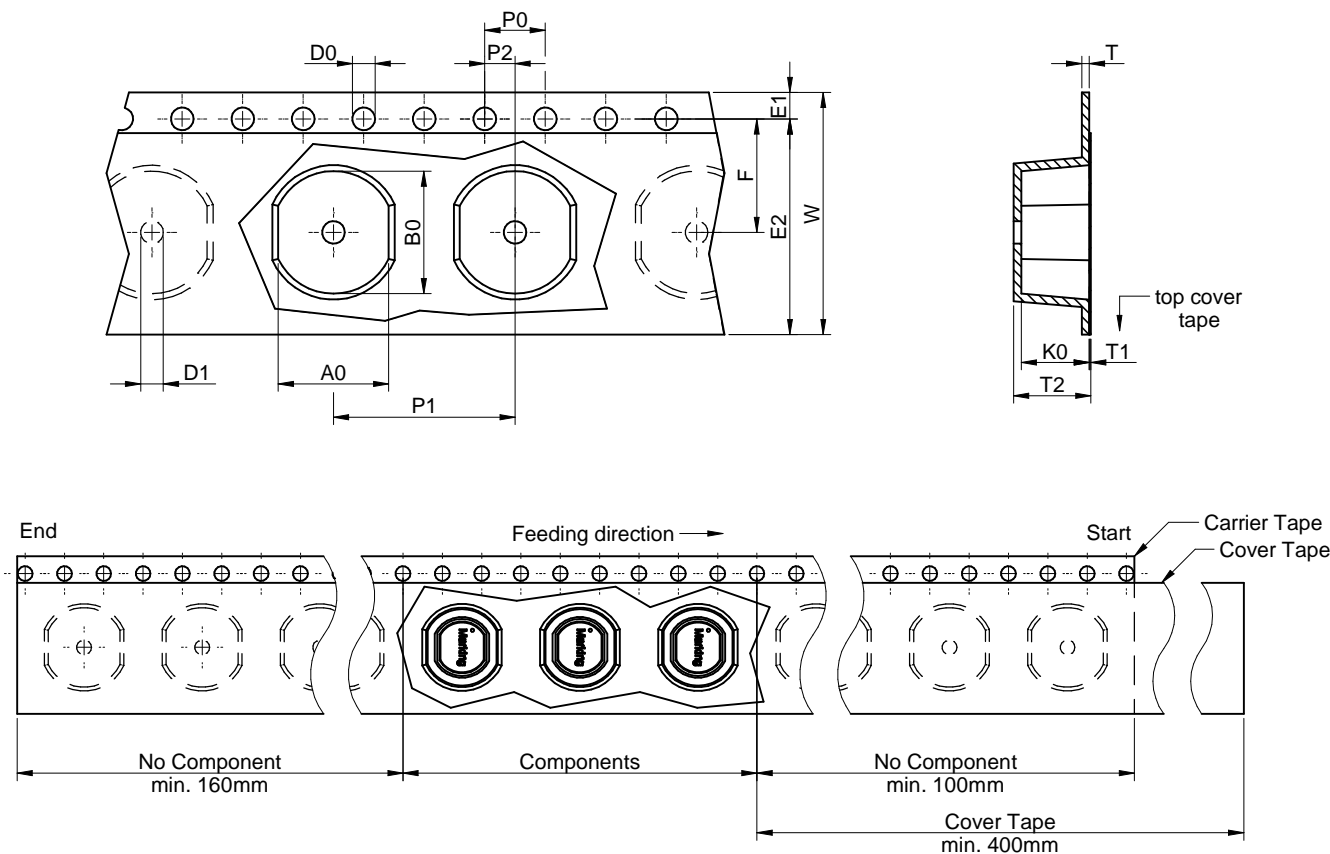
**Typical Temperature Rise vs. Current Characteristics:**
