Overvoltage:

Avoid any overvoltage and do not apply a continuous overvoltage. If an overvoltage is applied to the capacitor, the leakage current can increase drastically. The applied working voltage is not allowed to exceed the rated working voltage of the specific capacitor.



Ripple current:

The applied ripple current shall not exceed the specified maximum ripple current of the capacitor. If a higher ripple current as permitted






