The CHERRY UM POP FILTER was designed to meet the exact requirements of the CHERRY UM MIC SERIES (CHERRY UM 3.0, CHERRY UUM 6.0 ADVANCED, CHERRY UM 9.0 PRO RGB). It can therefore be attached without any problem to any of the three microphones: Simply attach it between the microphone and the stand and tighten with the help of a small knob – and you're ready to start recording. The sleek design does not detract from the elegant look of the microphone.

## Adjustable and universal microphone arm for more space to work

If you only intend to record a podcast or make a video call, it is usually sufficient to simply place the microphone on your desk. However, if you are dealing with situations where you need to use the keyboard and/or mouse at the same time as speaking, it is important to have enough space to move. In situations like these, the CHERRY MA 3.0 UNI microphone holder is a good choice.

Thanks to its sturdy aluminum swivel arm, the angle of the microphone arm can be freely adjusted, and the microphone can thus be optimally positioned. The classic black design of the arm and the high-quality workmanship complete the package.

The microphone arm is not called “UNI” for nothing – not only does it support the microphones of the CHERRY UM MICROPHONE SERIES, but also a variety of USB microphones and is therefore universally applicable. The CHERRY MA 3.0 UNI has a 3/8" threaded connector, and a 5/8" adapter is also included. With a net weight of 2.85 lbs, it is capable of carrying microphones weighing up to 3.31 lbs.

In addition, there is a practical cable slot in which both standard XLR and USB cables can be easily hidden. Simply attach to the desk using a clamp, the MA 3.0 UNI mic arm takes up very little space and ensures that the microphone remains stable and securely in place!

## Multifunctional and universal microphone arm with integrated USB hub

A microphone arm provides you with the space necessary to be able to speak into the microphone while actively using the mouse and/or keyboard. For this reason, the CHERRY MA 6.0 UNI USB is especially recommended for live streams, gaming videos or video conferences. It is made entirely of aluminum and can be conveniently attached via a table clamp. Thanks to its joints, the microphone holder can be easily adjusted, and the microphone optimally positioned.

The “UNI” addition speaks for itself and clarifies how universally the microphone arm can be used: A variety of USB microphones are compatible with the arm, not just microphones from the CHERRY UM MICROPHONE SERIES. The existing 3/8" threaded connection can be easily extended with the included 5/8" adapter. With a net weight of 2.24 lbs, the mic arm stably holds USB microphones of up to 1.76 lbs in position.

Furthermore, the arm has a built-in USB hub with two ports (5V/2A). This allows another device to also be connected in addition to the USB microphone. On top of that, a total of four connection cables are included with the CHERRY MIC ARM 6.0 UNI USB, which means you are well equipped for all eventualities: USB-A to USB-B, mini-USB, micro-USB and USB-C

With the CHERRY MA 6.0 UNI USB, tangled cables are a thing of the past. An 8.2 ft USB cable has been routed inside the arm, which means you can keep your workspace tidy at all times.
